## PARTIES

1. This Memorandum of Understanding (MOU) is entered into by and between Lafayette Police Department (LPD) and South Louisiana Community College (SLCC). Nothing in this MOU should be constructed as limiting or impeding the basic spirit of cooperation which exists between these entities.

## **BACKGROUND**

2. Act 172 of the 2015 Regular Session of the Louisiana Legislature, as amended by Acts 439 and 472 of the 2021 Regular Session of the Louisiana Legislature, now Louisiana Revised Statutes 17:3399.11 through 17:3399.17 requires that all public institutions of higher education enter into memorandum of agreement with local law enforcement agencies to clearly delineate the responsibilities and share information, in accordance with applicable state and federal confidentiality laws regarding power-based violence (as defined in La. R.S. 17:3399.11(5)), including trends occurring against students at institutions of higher education located in Lafayette Parish. Prior collaborations among the different agencies, have until this time, been informal and unwritten agreements. With signature to this MOU, all representatives are demonstrating a commitment to the requirement of Act 172.

#### **PURPOSE**

3. This working agreement is recognized as a cooperative, collaborative commitment between LPD and SLCC to delineate responsibilities and share information related to sexually oriented criminal offenses, and as proof of commitment as acknowledged by the signature of each agency's representative.

#### **LPD RESPONSIBILITIES**

- 4. Designates a liaison to serve and work with SLCC to serve as the agency's contact person;
- 5. Maintain communication and contact with SLCC, to the extent that they are able without hampering or jeopardizing their own investigation, including meeting with the SLCC designated security lead to assist that institution in resolving power-based offenses (as defined in La. R.S. 17:3399.11(5)) that may have occurred on their campuses or involved a student as a victim or an accused and to promote the proper methods of preservation of evidence;
- 6. Notify SLCC, to the extent they are able with respect to any confidentiality requirements, of any report to LPD of a power-based offense that may have occurred on their campuses or involved a student as a victim or an accused;
- Coordinate investigations, to the extent that they are able without hampering or jeopardizing their own investigation, to assure that any reported incident involving powerbased offenses that may have occurred on their campuses or involve a student as a victim or an accused is fully investigated;
- 8. Assist in the development and implementation of training for the Institution of sharing information and conducting investigations into power-based offenses that may have



occurred on their campuses or involve a student as a victim of an accused is fully investigated;

- 9. Share general information about power-based offenses that may have occurred on their campuses or involved a student as a victim or an accused to improve campus safety;
- 10. Develop and support the policies and procedures to establish and maintain the communication related to this MOU between all signatories to this MOU.

In reference to the above responsibilities of LPD, it is acknowledged LPD's responsibilities only pertain to those power-based offenses reported to LPD. LPD is not responsible for power-based offenses not reported to LPD.

## **SLCC RESPONSIBILITIES**

- 11. Designate a liaison to serve and work with LPD to serve as the agency's contact person;
- 12. Maintain communication and contact with LPD to the extent that they are able without hampering or jeopardizing their own investigation to assist the Institution in resolving sexually oriented criminal offenses that may have occurred on their campuses or involved a student as a victim or an accused and to promote the proper methods of preservation of evidence.
- 13. Notify LPD to the extent they are able with respect to any confidentiality requirement, of any report of a sexually oriented criminal offense that may have occurred on their campuses or involved a student as a victim or an accused;
- 14. Coordinate investigations, to the extent that they are able without hampering or jeopardizing their own investigation, to assure that any reported incident involving sexually oriented criminal offenses that may have occurred on their campuses or involved a student as a victim or an accused is fully investigated;
- 15. Assist in the development and implementation of training for the Institution of r sharing information and conducting investigations into sexually oriented criminal offenses that may have occurred on their campuses or involved a student as a victim or an accused is fully investigated;
- Share general information about sexually oriented criminal offenses that may have occurred on their campuses or involved a student as a victim or an accused to improve campus safety;
- 17. Develop and support the policies and procedures to establish and maintain the communication between all signatories to this MOU.

#### **TERM**

18. This MOU agreement shall remain in effect until cancelled.

## **CANCELLATION**

19. This MOU agreement may be cancelled at any time by either party upon written notice to the LPD or SLCC Chancellor.

The Parties acknowledge that the unique circumstances of individual cases may give rise to issues not addressed by this MOU, which may necessitate further discussion and agreement.

- A. The parties agree to work together regarding sexual assault awareness and reporting on and near the campus of South Louisiana Community College to facilitate the issuance of Clery Act required timely warnings and emergency notifications.
- B. The parties agree to share relevant documentation, as allowable by federal and state law, regarding reported sexual assaults on or near campus or as experienced by students or employees of South Louisiana Community College so as to assure delivery of appropriate services, to facilitate full and fair disciplinary investigations, to prevent acts of retaliation against the victim or witnesses, and to assess special threats posed by offenders, within the respective jurisdictions as part of an overall effort to prevent the occurrence of similar crimes.
- C. The parties agree to meet at least once a year to address the effectiveness of their prevention and response policies, procedures, and efforts.

- 9. Share general information about sexually oriented criminal offenses that may have occurred on their campuses or involved a student as a victim or an accused to improve campus safety;
- 10. Develop and support the policies and procedures to establish and maintain the communication between all signatories to this MOU.

## **SLCC RESPONSIBILITIES**

- 11. Designate a liaison to serve and work with CPD to serve as the agency's contact person;
- 12. Maintain communication and contact with CPD to the extent that they are able without hampering or jeopardizing their own investigation to assist the Institution in resolving sexually oriented criminal offenses that may have occurred on their campuses or involved a student as a victim or an accused and to promote the proper methods of preservation of evidence.
- 13. Notify CPD to the extent they are able with respect to any confidentiality requirement, of any report of a sexually oriented criminal offense that may have occurred on their campuses or involved a student as a victim or an accused;
- 14. Coordinate investigations, to the extent that they are able without hampering or jeopardizing their own investigation, to assure that any reported incident involving sexually oriented criminal offenses that may have occurred on their campuses or involved a student as a victim or an accused is fully investigated;
- 15. Assist in the development and implementation of training for the Institution of r sharing information and conducting investigations into sexually oriented criminal offenses that may have occurred on their campuses or involved a student as a victim or an accused is fully investigated;

# MEMORANDUM OF UNDERSTANDING BETWEEN MORGAN CITY POLICE DEPARTMENT AND SOUTH LOUISIANA COMMUNITY COLLEGE

#### PARTIES

1. This Memorandum of Understanding (MOU) is entered into by and between Morgan City Police Department (MCPD) and South Louisiana Community College (SLCC). Nothing in this MOU should be constructed as limiting or impeding the basic spirit of cooperation which exists between these entities.

#### BACKGROUND

2. Act 172 of the 2015 Regular Session of the Louisiana Legislature, now Louisiana Revised Statutes 17:3351 (H), 17:3399.11 and 17:3399.12 requires that all public institutions of higher education enter into memorandum of agreement with local law enforcement agencies to clearly delineate the responsibilities and share information, in accordance with applicable state and federal confidentiality laws regarding sexually oriented criminal offenses, including trends occurring against students at institutions of higher education located in St. Mary Parish. Prior collaborations among the different agencies, have until this time, been informal and unwritten agreements. With signature to this MOU, all representatives are demonstrating a commitment to the requirement of Act 172.

#### **PURPOSE**

3. This working agreement is recognized as a cooperative, collaborative commitment between MCPD and SLCC to delineate responsibilities and share information related to sexually oriented criminal offenses, and as proof of commitment as acknowledged by the signature of each agency's representative.

#### MCPD RESPONSIBILITIES

- 4. Designates a liaison to serve and work with SLCC to serve as the agency's contact person;
- 5. Maintain communication and contact with SLCC, to the extent that they are able without hampering or jeopardizing their own investigation, including meeting with the SLCC designated security lead to assist that institution in resolving sexually oriented criminal offenses that may have occurred on their campuses or involved a student as a victim or an accused and to promote the proper methods of preservation of evidence;
- 6. Notify SLCC, to the extent they are able with respect to any confidentiality requirements, of any report of a sexually oriented criminal offense that may have occurred on their campuses or involved a student as a victim or an accused;
- 7. Coordinate investigations, to the extent that they are able without hampering or jeopardizing their own investigation, to assure that any reported incident involving sexually oriented criminal offenses that may have occurred on their campuses or involve a student as a victim or an accused is fully investigated;
