

## **Applying to Aviation Maintenance Technology**

South Louisiana Community College's (SLCC) Aviation Maintenance Technology Program (AVMT) is proud to offer a degree program that will equip you with the knowledge and skill required to find a job in aircraft maintenance, repair, overhaul, modification or other maintenance-related fields. The program consists of general education classes, aviation fundamentals, airframe maintenance, and powerplant maintenance courses. Upon completion, SLCC's Associates Degree Program in Aviation Maintenance Technology will have guided students to earn the following Federal Aviation Administration (FAA) certificates/ratings and college degree:

- FAA Airframe & Powerplant Mechanic Certifications
- Associate of Applied Science Degree in Aviation Maintenance Technology

This program's mission is to provide a safe training facility and healthy learning environment that will prepare students for certification by the Federal Aviation Administration in Airframe and Powerplant Maintenance. Students completing the Aviation Maintenance Technology program will be able to do the following:

- Pass Federal Aviation Administration (FAA) Airframe, Powerplant, or both certifications through written, oral, & practical examination.
- Demonstrate competence in the utilization of basic tools in accomplishing federal (FAA) curriculum requirements.
- Display the ability to interpret and apply maintenance manual requirements to aircraft maintenance tasks.

## **Attendance Requirements**

The Federal Aviation Administration (FAA) requires each student attend all required course hours. Any absences and missed time, **excused or unexcused**, must be made up before or after school hours. Attendance and make up hours are documented and must be completed before receiving authorization approving a student for Federal Aviation Administration testing. Excessive unexcused absences may result in failure of a course.

1. A personal letter of recommendation
2. A professional or business letter of recommendation (ex: supervisor of current employment, someone in aviation industry, high school counselor)
3. One-page response describing your **Interest in Aviation and Career Goals** (one page double spaced, Times New Roman, 12 pt. font)
4. Completed AVMT Enrollment Questionnaire found on the last page. (Complete, print and scan as a PDF)

Use the following naming conventions to save all files being submitted:

1. Last Name. First Name. Personal Recommendation
2. Last Name. First Name. Professional Recommendation
3. Last Name. First Name. Interest and Career Goals
4. Last Name. First Name. Enrollment Questionnaire

To be eligible to register for AVMT courses, students must have successfully passed both ENGL 1010 – Rhetoric & Composition and MATH 1105 – College Algebra (or equivalent courses) before the first AVMT class begins.
