Need a 2019 Federal Tax Return Transcript? You have options!

A 2019 IRS Tax Return Transcript may be obtained through:

- Get Transcript by Mail Go to www.irs.gov, click "Get Your Tax Record." Click "Get Transcript by Mail." Make sure to request the "Return Transcript" and NOT the "Account Transcript." The transcript is generally received within 10 business days from the IRS's receipt of the online request.
- <u>Get Transcript Online</u> Go to <u>www.irs.gov</u>, click "Get Your Tax Record." Click "Get Transcript Online." Make sure to request the "Return Transcript" and **NOT** the "Account Transcript." To use the Get Transcript Online tool, the user must have (I) access to a valid email address, (2) a text-enabled mobile phone (pay-as-you-go plans cannot be used) in the user's name, and (3) specific financial account numbers (such as a credit card number or an account number for a home mortgage or auto loan). The transcript displays online upon successful completion of the IRS's two-step authentication.
- <u>Automated Telephone Request</u> I-800-908-9946. Transcript is generally received within 10 business days from the IRS's receipt of the telephone request.
- <u>Paper Request Form</u> IRS Form 4506T-EZ or IRS Form 4506-T. The transcript is generally received within 10 business days from the IRS's receipt of the paper request form. Follow this link to retrieve the 4506-T form https://www.irs.gov/pub/irs-pdf/f4506t.pdf.

Need to request a Non-Filing Letter and Wage & Income Transcript?

- Wage and Income Transcript is available to retrieve using Get Transcript Online or Form 4506-T. Additional information is provided above. Alternatively, students may request a wage record from their local unemployment office.
- **Verification of Non-filing Letter** is available to retrieve using Get Transcript Online or Form 4506-T. Additional information is provided above. Complete each section, check box 7 for verification of nonfiling letter, and mail to the address located on page 2 of the 4506-T form.

Filed an Amended IRS Income Tax Return (1040X)?

An individual who filed an amended IRS income tax return for tax year 2019 must provide the documents below:

• **Signed** copy of the 2019 IRS Form 1040X, "Amended U.S. Individual Income Tax Return," that was filed with the IRS **OR** Record of Account obtainable from the IRS (see instructions above).

AND

2019 signed IRS Tax Return Transcript <u>OR</u> 2019 signed IRS Form 1040 and the applicable schedules that were filed with the IRS.
